- B) Quotation must be in the enclosed prescribed performa(Annexure-2) on the letter head of the firm duly signed by the proprietor/partner/Director or their authorized representative, in case of signing of Quotation by the authorized representative letter of authorization must be attached with the quotation.
- c) Rates must be Quoted in Indian rupees(INR) and as per the format specified taxes extra if any must be written separately.
- D) Rates must be quoted for basis(including Freight charges, Insurance, installation. etc.)
- E) No overwriting or cutting is permitted in rates. if found, the Quotation shall be summarily rejected.
- F) The rates quoted must be valid for 30 days minimum from the dates of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.



